ADDITIONAL TERMS FOR THOSE APPOINTED BY ATHLETES AS AGENTS

These are additional terms applicable to those referred to in the Cucu Influencer Agreement as 'Agents'. Terms which are capitalised bear the meaning ascribed to them in the Influencer Agreement.

Agent: An Agent may be a sports marketing agency, a community manager, the club or franchise for which the athlete performs, or any other person or entity validly and currently invested with express written authority to enter into contracts for promotional activity on the athlete's behalf.

If you do not fit that description, do not activate your Agent Account.

By signing up as an Agent, you are re-affirming your agreement to the terms of the Influencer Agreement.

By activating the dashboard facility made available on the Cucu mobile app ("Agent Account") you warrant and undertake to Cucu Limited that you are, and will at all times during your use of the Agent Account be, the Agent (as described above) of the athlete whose social media accounts are listed in your Agent Account.

By creating an Influencer Profile, you warrant, represent and undertake to Cucu and the Brand (as defined in the Influencer Agreement) that you have the express written authority of the Influencer to (i) create the Influencer Profile, (ii) fully manage the Influencer Profile, (iii) accept any Proposal on the Influencer's behalf (iv) submit any Influencer-Generated Content (as defined in the Influencer Agreement), (v) receive payment on behalf of the Influencer in respect of the Campaign specified in the Proposal.

You or the Influencer may specify in your Agent Account or notify Cucu at [info@cucusports.com] if you wish payments to be split between you and the Influencer, or for the entire payment to be made to You. In case of the latter, You undertake to pay the Influencer all sums due to the him or her in respect of such sums received.

You undertake to ensure that you adhere to all applicable laws and regulations (including tax and disclosure laws and regulations) in respect of all payments received by you (either on your own account or on behalf of an Influencer).

You may terminate your agreement to these additional terms, at any time, by giving us three months notice by email to info@cucusports.com. Such termination will not affect any obligation to undertake or fulfil any Campaigns agreed in advance of the date of such termination.

During the period you are registered to use your Agent Account, you undertake not to act as agent or in any similar capacity, in relation to any performer or athlete you represent in Cucu Sports, in respect of any other influencer marketing or social media marketing platform or service.

You agree to indemnify and hold harmless Cucu Sports Ltd, the Brand, our and their officers, directors, partners, agents, and employees from and against any loss, liability, claim or demand made by the Influencer or any third party, including reasonable legal advisers' fees, due to or arising out of your use of

the Agent Account or our payment of any sums to you, or any breach of the representations, warranties and undertakings you make in these terms.
